

THE “New Year, New-Found Time” SWEEPSTAKES RULES AND REGULATIONS

- 1. NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES:** The “New Year, New-Found Time” SWEEPSTAKES (the “Sweepstakes”) is sponsored by Great Clips, Inc (the “Sweepstakes Provider”). The Sweepstakes entry period begins on Tuesday, January 9, 2012, at 8:00 AM Central Time and ends on Friday, February 10, 2012, at 11:59 PM Central Time (the “Entry Period”).
- 2. HOW TO ENTER:** Online entries only. To enter the Sweepstakes, visit the EverythingGreat website at www.everythinggreat.com (the “Sweepstakes Site”) at any time during the Entry Period and submit your entry on what you will do with your “new-found time.” To be eligible to participate, each entrant will be asked to submit an official entry form, which may include, among other things, his/her name, address, e-mail address, age and related registration information as prompted (the “Official Entry Form”) along with a photo. Limit of one entry per person. Duplicate entries from the same e-mail address/person/household will be automatically eliminated without notice to the entrant. Where a dispute arises about who submitted an entry, the entry will be deemed submitted by the holder of the e-mail account. Odds of winning depend on the number of eligible entries received. No entries will be acknowledged or returned.
- 3. ELIGIBILITY:** This Sweepstakes is open to individuals 18 and older who are legal residents of the U.S. and Canada including the District of Columbia (the “Eligibility Area”). The Selected Entrant will be notified on or about February 20, 2012, by notification through email. Failure of the Selected Entrant to respond within a reasonable time frame (but not longer than 96 hours) from such

notification referred to above may result in disqualification and the selection of another entrant from among all eligible entries received. By entering the drawing, each entrant agrees to be bound by these Official Rules and the decisions of the Sweepstakes Provider. In the event of non-compliance for any reason, including the inability to accept the Prize, an alternate entrant may be selected.

Headings and captions are used in these Official Rules solely for convenience of reference, and shall not be deemed to affect in any manner the meaning or intent of these Official Rules or any provision hereof.
